<ul style="list-style-type: none"> <li>The Fund is a global asset allocation fund which may invest up to 100% in equity securities but generally it will intend to mitigate risk through the adequate diversification among different asset classes such as fixed income, and/or other UCITS, with a capital growth investment objective.</li> <li>Concentration among securities will comply with the UCITS regulations.</li> <li>The Fund has daily liquidity on business days in Luxembourg.</li> <li>The Fund has a very wide range of discretion in its investment policy aiming to quickly adapt to market circumstances.</li> <li>The Fund may use derivatives for hedging and investing purposes.</li> <li>The Fund does not follow any market benchmark of any kind.</li> <li>The Fund may not invest more than 10% of its assets in units of other UCITS or UCIs</li> <li>The Fund is an “accumulation fund” and therefore no dividends or income of any kind is distributed to investors.</li> </ul>	<ul style="list-style-type: none"> <li>The Fund may invest in debt securities of any kind issued within any Regulated Market, corporate or sovereign’s issuers.</li> <li>The Fund performance will be the result of the discretionary portfolio management within the UCITS Investment Limits.</li> <li>The Investment Policy is based on an unconstrained style (adaptive to market circumstances).</li> <li>The Fund is actively managed without reference to any benchmark, meaning that the Manager has full discretion over the composition of the Fund’s portfolio, subject to the stated investment objectives and policies.</li> <li>The Investment Policy intends to search for undervalued securities (value investing) and markets.</li> <li>Portfolio transaction costs will have a material impact on performance</li> <li>The Fund has a long term horizon and the minimum recommended term for holding units is 5 years.</li> <li>Under normal market conditions the Fund’s equity allocation will not be less than 10% of the Fund’s net assets.</li> </ul>
